Providing oral health to rural communities and orphanages. During 2017 we did our regular visit to Zambia's largest orphanage, Kassi as well as a visit to the village of Serenje where we screened 619 patients. Screening involved using the Zambian Dental School students to assist in teaching the villagers on proper dental hygiene, and perform dental exams. Each patient was rated by severity of oral health on a 0 thru 2 scale, 0 being no problems and 1 and 2 those with issues requiring attention, with 2 being the most severe. 42% in the 0 group, 23% in the 1 group and 35% in the 2 group.
